(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Coeker Spaniel (soild color black, ASCOB, particolor), Baseles (not exceeding 15 in, over 13 in, but not exceeding 15 in, ), Dachshunds (longhaired, smooth, variebrired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, 10y), Chilubuhuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which, according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship
- then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division. 3. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided,
